

WHEREAS, accused **Zahir Zakir Jafar S/O Zakir Jafar, caste Memon** aged about 28/29 years R/O House No.07, Street No.60, Sector F-7-4 Islamabad, at present confined in Central Jail Adyala, Rawalpindi involved in the above mentioned criminal case and vide judgment dated 24.02.2022 he has been convicted before me, **Muhammad Atta Rabbani, Additional Sessions Judge West-Islamabad**, as under:

- i. **U/S 302(b) P.P.C** and is sentenced to death as Tazir. He be hanged by his neck till he is dead. He is directed to pay Rs.500,000/- (Five lacs) as compensation to the legal heir of the deceased Mst.Noor Muqadam as required U/S 544-A Cr.P.C. In case of non-payment of compensation amount it shall be realized as arrears of land revenue. In case of non-realization of said amount the convict shall have to undergo Six Months (06) S.I. However the death sentence awarded to the convict will be subject to confirmation by the Hon'ble Islamabad High Court, Islamabad. Reference U/S 374 Cr.P.C be immediately submitted to the Hon'ble Islamabad High Court, Islamabad for confirmation of the awarded sentence.

- ii. U/S 364 P.P.C and is sentenced to Ten years (10) R.I and with fine of Rs.100,000/- (one lac). In default of payment of fine he shall undergo Two months (02) S.I.
- iii. U/S 342 P.P.C and is sentenced to One year (01) R.I.
- iv. U/S 376(1) P.P.C and is sentenced to Twenty Five years (25) R.I with fine of Rs.200,000/- (Two lacs). In default of payment of fine he shall undergo Three months (03) S.I.

The sentences of imprisonment shall run concurrently and the accused is granted benefit of **section 382(B) Cr.P.C.**

This is to authorize and require you, the Superintendent Central Jail Adyala, Rawalpindi to receive the above said convict alongwith this warrant to keep in your custody in the jail as per law is required to serve the sentence awarded to him.

- ii. U/S 368 P.P.C and is sentenced for imprisonment of ten year (10) R.I with fine of Rs.100,000/- (one lac). In default of payment of fine he shall undergo two months (02) S.I.
- iii. U/S 176 P.P.C and is sentenced for imprisonment of One month (01) S.I.
- iv. U/S 118 P.P.C and is sentenced to Seven year (07) R.I with fine of Rs.100,000/- (One lac) each. In default of payment of fine they shall undergo two months (02) S.I.

The sentences of imprisonment shall run concurrently and the accused is granted benefit of section 382(B) Cr.P.C.

i. U/S 109 P.P.C read with section 364 P.P.C and is sentenced
